the Region One Adult Volunteer of the Year, and after tallying the results, our very own Debbie DelGiornio won the title. Those of us at ESDCTA are proud of Debbie's support on behalf of our organization and all she has done for NAJYRC. Debbie's accomplishments will be saluted at an upcoming ESDCTA event. Lisa invited GMO'S to become involved in Regional activities. She encouraged us to send articles and photos of interesting events to her Region One email.

Next, I attended the Technical Delegate Session, which offers information that is also important for licensed show secretaries. A Technical Delegate is required to have evaluation forms randomly filled out and sent to USDF. The purpose of these forms is to compare others' remarks on the event versus the observations of the TD. It is now mandatory for bit checkers to wear 2 gloves per horse, one glove used per side and to discard them after each horse. Another note, Judges will be allowed to have cell phones in the booth but must turn them off. Phones are only to be used in an emergency.

Competition Management touched on two highlighted subjects. The first was that USEF added a fee of \$1.50 per horse per show. It was firmly stated that show secretaries should not bring attention to the fee on the prize list or on the entry forms. It was recommended to add it to the office fee, indicating

that this extra cost is beyond the control of the management. The second major topic was the gradual elimination of Intermediate Test II. Two new tests being offered are Intermediate Test A and Intermediate Test B referred to as the Medium Tour. Scores from the I-B will be used as the qualifier. Management is urged to drop I-2 and substitute I-B on future prize lists. Please refer to USDF for detailed information on the tests changes for 2014.

USDF Conventions always feature educational seminars that are worth fitting into the busy schedule of required meetings. The equine medical sessions are presented by esteemed veterinarians and are packed full of information. My favorite this year was Neurologic Disease in Dressage Horses by Dr. Clara Fenger. Although on Sunday many were eager to get home due to an impending snowstorm, a dedicated group of us stuck around to hear Charles de Kunffy share his insights and theories on classical training. Mr. de Kunffy was inducted into the Roemer Hall of Fame during the Gala Awards Banquet.

The Board of Governors assemblies were brief and light-hearted this year. It was obvious the BOG members were proud of the success of the Inaugural U S Dressage Finals held Nov 7–10, 2013, at the famous Kentucky Horse Park. Competitors from all nine Regions said they were honored to have been selected to represent their Region at the first competition of its kind in the US. The atmosphere was electric and the outstanding quality of riding was apparent from Training Level to Grand Prix. Competitors, judges, staff and audience alike pronounced that the US Dressage Finals were equal to an Olympic experience.

Sunday afternoon brought the close of the 2013 Convention, as well as the Lexington Airport. The majority of conventioneers had to reschedule flights for another day or another airport. Sincere well wishes of safe travel were exchanged as we went our separate ways heading towards home. After 10 hours of sitting in airports, Nancy and I were grateful to see the pristine sight of the snow-covered ground of our Lehigh Valley terminal.


## Our Nominee for NJ Equestrian of the Year: Kylie Dickinson!

### NO TAXATION WITHOUT REPRESENTATION

Finally, some good news. New Jersey Assemblyman, Ronald S. Dancer (R), introduced legislation (bill A4479) to allow that the rental of certain stable stalls be exempt from tax charges. This measure will be a big help to New Jersey's horse industry.

"Confusion regarding the taxability of horse boarding and other services has placed New Jersey horse boarding businesses at a competitive disadvantage," said Mr. Dancer. "This legislation is needed to level the playing field with our competing neighboring states of New York, Pennsylvania, and Delaware."

"Surrounding states do not collect tax on charges for boarding horses, but in our state, the failure to clarify tax collection responsibilities for horse boarding and other services has had a severe negative impact on business. Exempting these services from uncustomary taxation eliminates the confusion and reduce the higher cost of doing business in New Jersey as compared to our neighboring and competing states," added Mr. Dancer.

# USEF Rider Tests: What Are They, How Are They Scored, and Where Can You Find Them?

The USEF and USDF worked in conjunction to create three new tests to offer riders beginning in the 2014 show year. These tests are called "rider tests." They were developed to recognize and evaluate a rider's skill level. There are rider tests for Training, First and Second Level. The patterns are consistent with those in the standard dressage tests, but with more challenging sequences. They require great accuracy and quick responses by both horse and rider. For example, in the second level rider test, the rider performs the shoulder-in and travers on the centerline. Lisa Gorretta, who chaired the rider-test subcommittee, says "The new tests are designed to evaluate the proficiency of the rider relative to the requirements of the given level, without giving extra credit for the horse's gaits, impulsion, and submission." This means, you don't need to be riding the big, fancy horse to score well and win the class.

The rider tests are not scored in the traditional manner. There are no scores for each individual movement. The judge scores the test at the end where the usual collective marks are. There are only five scores given – all pertaining to the rider: rider's position, rider's correct and effective use of aids, horse's response and performance, accuracy of the exercises, and harmony between horse and rider. Each score has a coefficient of 2 and can be given in decimal points (i.e., 7.3 or 8.2). There is also a summary section for the judge to write additional comments. Complete directives are given on the score sheets.

The tests are very challenging and clearly highlight the rider's ability to ride at each given level, rather than highlighting the horse's innate abilities. These tests are a wonderful opportunity for riders to showcase and receive feedback on their skills.

As a member of ESDCTA, a person is automatically a GM (General Member) of the USDF (United States Dressage Foundation), and has access to the USDF e-TRAK program. You can sign in on the USDF Website (USDF.org) and go to e-TRAK and see videos and diagrams of the rider tests.

This is a great opportunity to get feedback and to learn how these tests ride and are scored. The dates for the clinic are Feb. 16, March 23 and May 4. Go to ESDCTA.org for more information. ### **USEA CONVENTION 2013 - FUN AND LEARNING**

This is my annual report from the USEA convention. This year it was in Cincinnati, OH, and I find myself fortunate to be one of the few attendees who was able to get there and back without much of an airport weather delay...4 hours was nothing compared to those who didn't get home until the next day. Anyway, on to business...

At this year's meeting I focused on attending Forums and Business Meetings so I could bring back the very important rule changes and other important things coming down the pike that pertain to "you" as a competitor. At the Board of Governors meeting and at several of the forums there was discussion of a new level of competition in the beginning stages of discussion. This new level of competition would probably be a 3'5" division that falls between Training and Preliminary. This way they can keep Training as it should be and not too technical, yet they can make better "move-up" courses that are more technical and yet not the full Prelim height. This was well received, but again is just in the discussion stages as they have quite a bit to talk about with naming the level, qualifications, and age limits, as well as prospective from course designers and organizers. The Board also had a discussion about getting more connected with unrecognized events and trying to make the people who compete at those events more aware of the USEA and what the benefits would be for jointing the organization. Discussion was made to have a representative table at these events to talk to people about it. The organization is concerned that we lose a lot of members after they graduate high school or finish Pony Club and go into college or get their new careers. They might come back in their 30s or 40s but the 20-somethings seem to disappear.

This membership gap led to the new initiative of the USEA to join up with the recently started Intercollegiate Eventing League (IET). The group was formed by a few college students interested in eventing who wanted to make it a college sport. There are a few colleges now who have teams but most of them are run separate from the university (re: funding), but in order to help bridge the gap with college-age USEA members, USEA wants to play a bigger role and stimulate more interest. One of the ways they want do this is to encourage organizers to consider hosting a Collegiate Team Challenge at their events, since there are only 2 that currently do (FENCE in SC and Chattahoochee in GA). Area II (our area), Area III (south of us) and Area I (north of us) are the most heavily dense areas with college eventing programs. It would only make sense to have more events in these areas with a Collegiate Team Challenge. These competitions are run exactly like other team competitions (Young Riders and Adult Rider team competitions). So, if you are reading this and at a university without an eventing team talk to you friends about starting one and look out for other events in this area starting to host a team challenge (maybe ESDCTA in Oct. will roll out the first Area II Collegiate Team Challenge?)! For more information you can go to <a href="http://www.intercollegiateeventing.com">http://www.intercollegiateeventing.com</a> or join their Facebook page to see where the competitions will be next!

For Adult Riders there was a lot of discussion around the new <u>Adult Rider Team Competitions</u> that will be run under a different format in 2014. This year there will be no Team Challenge held in 3 areas across the country (East, West, and Central). Instead, in 2014 the team competition will be held in combination with the American Eventing Championships (AEC's). For the next two years this competition is in September at Texas Rose Horse Park, and each USEA Area will be allowed to send 8 teams of 4 Adult Riders. Riders will have to qualify for the ATC's (Adult Team Championships) just like you have to qualify for the AEC's. However, you will also have to meet each specific area's requirements. These are all being talked about now in each area. Area II has decided that since not all Adult Riders will be able to go all the way to Texas, they are encouraging some of the Area's Event Organizers to run an <u>Area Team Championship</u> to help riders get qualifying scores and be placed on a team. At least one of the events in NJ are being considered for this competition so keep your eyes open as the competition season gets closer if you are interested. Now, remember that in order to qualify for these competitions you must be an Area II Adult Rider, which is separate from your USEA membership and the teams will be organized through each of these Adult Rider Area Coordinators. A few other things that were talked about but I am running out of room here to go into detail about included where does my entry money go and why on each Area's calendar and how they are trying to streamline the process of choosing
